The student and the student's parents had been advised on the charges against the student in writing, and had been advised of their due process rights. The student was provided with all due process rights required by law and District policy.

The Board has considered all of the evidence presented at the hearing and, based on the evidence, has reached the following conclusion: Student, 03/06/17:IRQ02, was guilty of: Sections IV.9, Section IV.9, "Physically assaulting a student associated with the District" and Section IV.5, "Possession of a Weapon" and State of Michigan Revised School Code-Section 380.1311a (2).

THEREFORE, it is resolved that Student 03/06/17:IRQ02, be permanently expelled from the Chippewa Valley School District. Student, 03/06/17:IRQ02, is prohibited from entering any premises owned, operated or controlled by the District or attending any District function.

MOTION #03/04/17-The Board of Education conducted a hearing on March 6, 2017, in an open session concerning the Administration's recommended expulsion of Student, 03/06/17:IRQ01.

The student and the student's parents had been advised on the charges against the student in writing, and had been advised of their due process rights. The student was provided with all due process rights required by law and District policy.

The Board has considered all of the evidence presented at the hearing and, based on the evidence, has reached the following conclusion: Student, 03/06/17:IRQ01, was guilty of: Sections IV.9, "Physically assaulting a student associated with the District" *and* Section IV.39, "Gross Misbehavior" *and* State of Michigan Revised School Code-*Section 380.1311a (2)*.

THEREFORE, it is resolved that Student 03/06/17:IRQ01, be permanently expelled from the Chippewa Valley School District. Student, 03/06/17:IRQ01, is prohibited from entering any premises owned, operated or controlled by the District or attending any District function.
