MOTION #12/01/18 – Moved by Member DeMuyck Zech and supported by Member Sobah to approve the General Consent Agenda to:

MOTION #12/05/18 – Moved by Member Bednard and supported by Member Patzert

that the Chippewa Valley Schools Board of Education conducted a hearing on December 3, 2018, in a closed session concerning the Administration’s recommended expulsion of Student 12/3/18;IMS01.

The Student and the Student’s parents had been advised on the charges against the Student in writing, and had been advised of their due process rights. The Student was provided with all due process rights required by law and District policy.

The Board has considered restorative practices and all of the evidence presented at the hearing and, based on the evidence, has reached the following conclusion: Student, 12/3/18;IMS01, was guilty of: Section IV.10, “*Verbally threatening a staff member/student/person associated with the District,*” and State of Michigan Revised School Code-*Section 380.1311a (2)*.

THEREFORE, it is resolved that Student 12/3/18;IMS01, is expelled from the Chippewa Valley School District, from December 3, 2018, through January 25, 2018. Student, 12/3/18;IMS01, is prohibited from entering any premises owned, operated or controlled by the District or attending any District function for the duration of the expulsion.

MOTION #12/06/18 – Moved by Member Bednard and supported by Member Patzert adjourn the meeting. **Ayes, all. Motion carried.**
